#### Note:

- 1. As per provisions of DCS Act and Rules, the defaulter members are not eligible to contest the elections, but they are entitled to cast their votes except those members against whom decree has been issued under Section 71. However, in case, if they make the payment of their amount in default before the date of filing of nomination to the society and produce the proof thereof before the Election Officer, they will not be treated as defaulters an shall be allowed to contest election. It is further informed that no person shall be eligible to contest if he incurs disqualification as laid down under Rule of DCS rules, 2007.(Candidate or his representative who wants to be present at the polling station shall only be allowed if he presents the negative covid19 test report of ICMR Approved Lab and the test should not be older than 48 hours.)
- 2. All the members are requested to bring the proof of their identification by way of Pass Book of the Society, Driving Licence, Identity Card issued by the Election Commission of India or any other documents related for their identification to facilitate the smooth conduct of election. All members before visiting the polling station shall fill the declaration form of Covid19, member not wearing mask shall not be allowed to enter in the polling station. Not more than 100 members are allowed to enter polling station at a time as per schedule (subject to passing thermal screening guidelines for covid19).
